From deeds we find that Alexander Lackey was in West Pennsborough township as early as 1784, and in 1791 other deeds show him buying at Sheriff's sale land in Tyrone tonship, 343 acres for \$753 pounds. This land he sold in the year1791 to Abraham Handis for \$1000 pounds having owned it from January to Decemebr 1791.

This accounts for the interest the family had in Perry county, of which Tyrone was aftetwards a part.L.E.F.

In the year 1793 we find Alexander Shortess and one Robert Lackey as joint owners of land in Rye township(from which Carroll was later cut off( \_ and Rye township had astaxables in the year 1820 when Perry was erected three of the Lackey family enrolled as tax payers viz

Lackey Family records Cumberland County, Penna page 2 continued Robert Leckey who had 25 acres of land Alexander Leckey who had 50 acres of land and John Leckey, Sr who had 100 acres of land.

From a casual reading it would seem that John Lackey might have been father of the Robert and Alexander entioned above and that there might possibly have been a John Leckey. Jr. also.

Perry County records should be of much interest in running down subsequent family records not to be found in Cumberland.

Deeds to lands held by one Robert Lackey in Rye township are shown in Cumberland county as early as 1793 and are of interest.

At an Orphans Court held in Carlislr for the county of Cumberland on March Term 1874we find the following record

The petition of Henry A Lackey, Sarah Jene Lackey, Margaret Ann Lackey, John W Lackey and Fannie A Lackey presented by their father and next friend John Lackey, respectfully represents that the petitioners are minors, children of Margaret Lackey of Dickinson township deceased under the age of 14 years and have no Guardian. They ask Court for appointment of suitable Guardians. The Court appoints Reuben Young of Carroll township, Perry County Guardian he to give strurity for \$500.

At an Orphans Court held in Carlisle for Cumberland County April Term

fourteen years was heard.minor children of ----- Lackey deceased. They

From an Orphans Court record dated May 5th 1873 we take the following Before the Judges of the Orphans Court of Perry County, Penna appeared Elizabeth Lackey widow of Benjamin Lackey, deceased, of Carroll township, who preferred a petition to the Court stating that her late husband died intestate and left the following heirs children under the age of 14 years who had no Guardian to take care of their persons and estates. Perry County, Penna records of the Lackey Family-

The very thorough se ch made of all wills and Administrations did not reveal the father of Mr Benjamin Lackey's grandfather the father of Akexander Lackey. It was necessary therefore to make a detailed and full search of every kind of record in the county and this was successful in unearthing a very interesting deed, which gave most unmitable genealogical background and authentic information as to the father of Alexander Lackey of Carroll township. The deed is the more valuable inasmuch as the man who made it Henry Lackey did not apparently make a will. Perhaps in thus transferring his land to his two sons he felt no need for further distribution and made any other distribution to pos ible daughters by gifts in his life time. this is of much greater value, the deed, shown below than if there had been a will also. There is a will of one Henry Lackey but he was the progenitor of Carson Lackey, and had a wife Rosannah. He also had another son William Lackey and only the wife and two children are named. This will was made in Carroll township also, in the year 1855, and he was doubtless some realtive perhaps a brother of Alexander not named by him in the deed herewith given.

Alexander Lackey from Henry Lackey, Tyrone township. Book F volume 1, page 359 dated 16th April 1828, recorded 1835

The deed recites that the conveyance is made between Henry Lackey of Tyrone township, and Elizabeth his wife of the first part, and William Alexander Lackey and William Lackey, sons of the said Henry Lackey and Elizabeth his w wife, the sum paid being \$500. Two tracts of land are sold to the two sons nmaed i tract granted to Henry Lackey by purchase from Thomas Smiley, on the 26th of December A.D 1794 comprising 100 acres, and the second tract the home of Henry Lackey, comprising 66 acres which was surveyed to the said Henry on June 2nd A.D 1819.

Note -Inasmuch as seven years elap sed after the deed was dated before it was recorded, it is possible that the deed's year of recording was also the year of the death of Henry Lackey father of xxxx Alexander and William Lackey

Page 3 Perry County data regarding the Lackey family

It is interesting in vi w of the fact that the will of Alexander Lackey made in the year 1866 does not mention wife-likely for the reason that she had died before the will was made-to find the first name of the wife in a deed made by Alexander in her life time. The deed says Alexander Lackey to William Lackey, Book B volume 1 page 198 recorded 1824.

The deed says that Alexander Lackey and wife Margaret, both of Tyrone township, sell for \$100 which was paid by William Lackey, land in Tyrone township, which was surveyed to Alexander and William Lackey together in the year 1820.

The fact that William and Alexander Lackey had land surveyed to them in the year 1820 shows that they were then men of 21 or thereabout, or they could not legally have held it in their own right. It makes it the easier to ascertain the age of the men

The names of 467 men appear in the section now Perry County(Perry was erected from Cumberland in the year 1820) and the name numbered as 54 is Henry Lackey (He was then if the names began with 18 year old boys avout the age of 20 in the year of the survey)

The date of the list's compilation was 4th Ferruary A.D 1793

This gives eligibility to membership in the Society of Daughters of 1812. As eligibility dates from Militia service following the Rev lution v viz 1784 to the end of the 1812 War period viz 1815.

I am certain that the original ancestor of the Perry branch is to be found in York county where I have made much investigation. Later I find the son and I ope the father of this Henry in Adams but he left no will and work is yet to be
